Automatic Debit Agreement Summary: I understand that I am purchasing a 2026 Pomme de Terre Golf Club membership to be paid over six monthly installments from April 1 through September 1, 2026. If my automatic payments begin after April, I agree to pay for any past-due months in advance before starting monthly withdrawals. (For example, if starting in May, I will pay both April and May dues in advance.) To begin automatic payments for a given month, this agreement must be completed by the 15th. I authorize Pomme de Terre Golf Club to initiate debit transactions from my account for the selected membership and related fees. I acknowledge that all ACH transactions must comply with U.S. banking regulations.
